1. Comprehensive Plan – 20-year Vision

- State Requirement - RCW 36.70A.070
- Requires updates every 8 years (June 30, 2025)
- Fluid (living) document – Can be amended yearly between March-November
- CP is implemented by the City's development regulations (zoning ordinance, critical areas ord., development standards, and water, wastewater, stormwater, and electric plans)

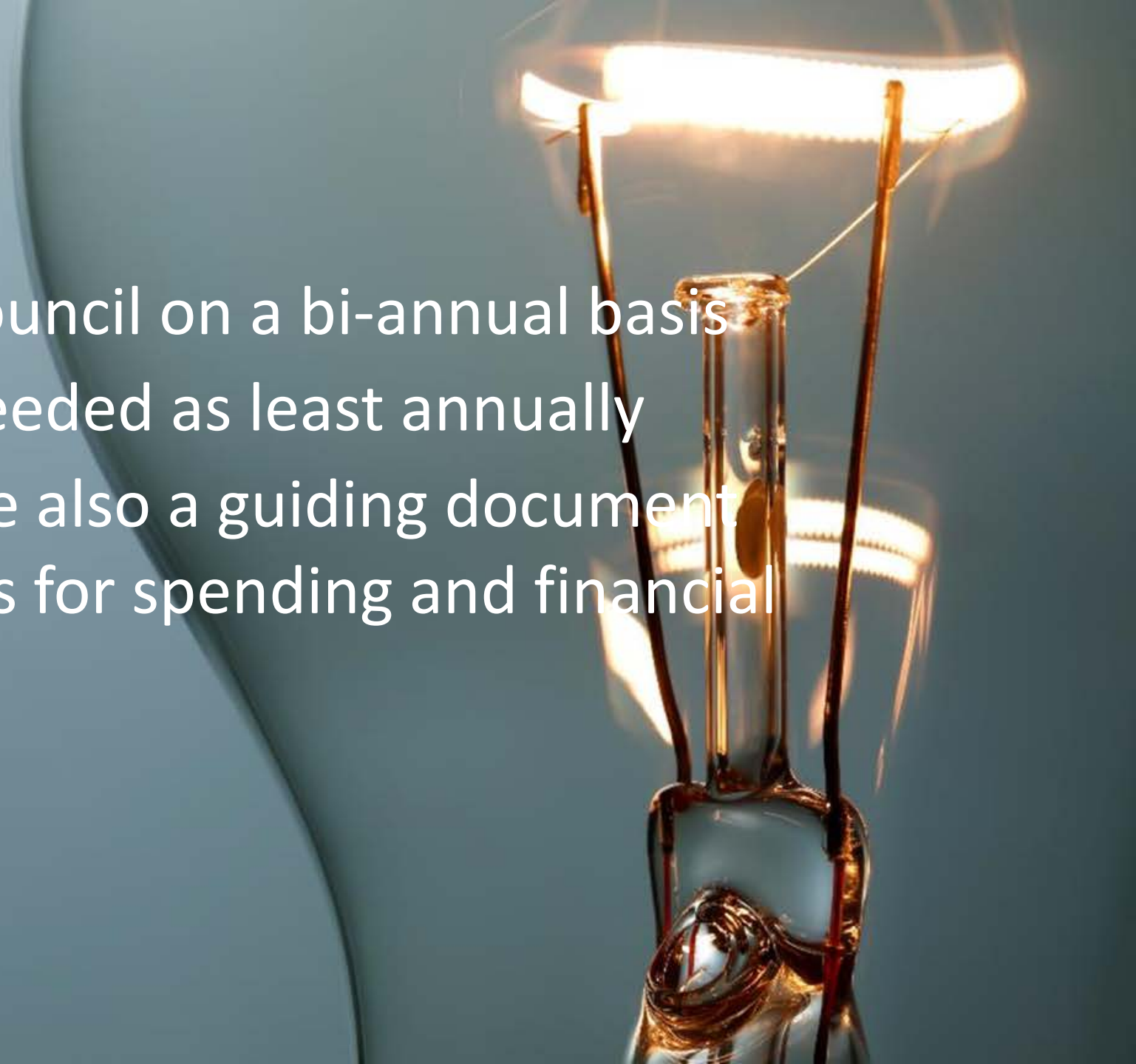
2. Centralia Municipal Code

- City's rules and regulations
- It is a fluid (living) document that maybe amended by the Council (depending on State and Federal laws)



3. City Budget

- Adopted by City Council on a bi-annual basis
- Amendments as needed as least annually
- Finance policies are also a guiding document
 - Establish the rules for spending and financial resources



4. Council Strategic Policies

- Council focused goals and policies
- Prioritizes direction for Council and Staff
- Fluid document
