



ENERGY STAR® APPLIANCE REBATE PROGRAM

Program Guidelines Effective April 1, 2022

Rebates for the purchase and installation of qualified Energy Star® certified appliances are available to all residential customers of Centralia City Light. The rebate is based on the appliance purchased. Rebates are as follows:

Energy Star® certified Clothes Washers – \$30.00-\$35.00, must provide water heater type (electric, gas, propane or other). Not all clothes washers will qualify for a rebate. Clothes washers must be Energy Star®-Certified.

Energy Star® certified Electric Clothes Dryer – \$50.00-\$175.00 depending on efficiency. Not all dryers will qualify for a rebate. Clothes dryers must be electric and be Energy Star®-Certified.

ONLY ONE APPLIANCE PER APPLICATION ALLOWED. Appliances must have been purchased after October 1, 2023 to be eligible for the rebate. All rebate requests must be submitted on or before September 13, 2025 to be eligible for payment. All applications must have a sales receipt attached. The submitted sales receipt must clearly identify the purchaser, make and model of the appliance purchased, as well as the purchase date. Rebates will **NOT** be paid to contractors, installers, distributors, or retailers.

Centralia City Light reserves the right to inspect and approve an applicant's appliance for conformity to program requirements. For more information regarding the Energy Efficient Appliance Rebate Program, please contact the Conservation Department at (360) 330-7512.
