

RESOLUTION NO. 2805

A RESOLUTION OF THE CITY OF CENTRALIA, WASHINGTON ADOPTING A REVISED AND EXTENDED SIX-YEAR TRANSPORTATION IMPROVEMENT PROGRAM.

WHEREAS, the City of Centralia ("City") adopted a six-year comprehensive transportation program pursuant to Chapter 35.77 of the Revised Code of Washington ("RCW");

WHEREAS, the City is required to annually review the work accomplished under the program and determine current city transportation needs in order to perpetually have advanced plans looking to the future for not less than six years as a guide in carrying out a coordinated transportation program;

WHEREAS, based on these findings, the City must prepare a revised and extended comprehensive transportation program, hold public hearings thereon, and adopt the revised program before July 1st of each year; and


WHEREAS, each one-year extension and revision shall be filed with the secretary of transportation after its adoption.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CENTRALIA, WASHINGTON:

Section 1. That, after duly publishing notice, the City Council held a public hearing on May 28, 2024 to hear and consider public comments on the proposed revisions to the Six-Year Transportation Improvement Program.

Section 2. That the revised and extended Six-Year Transportation Improvement Program presented to the City Council on June 25, 2024 is hereby approved and adopted.

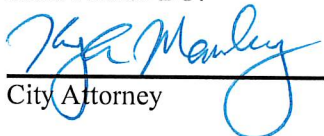
