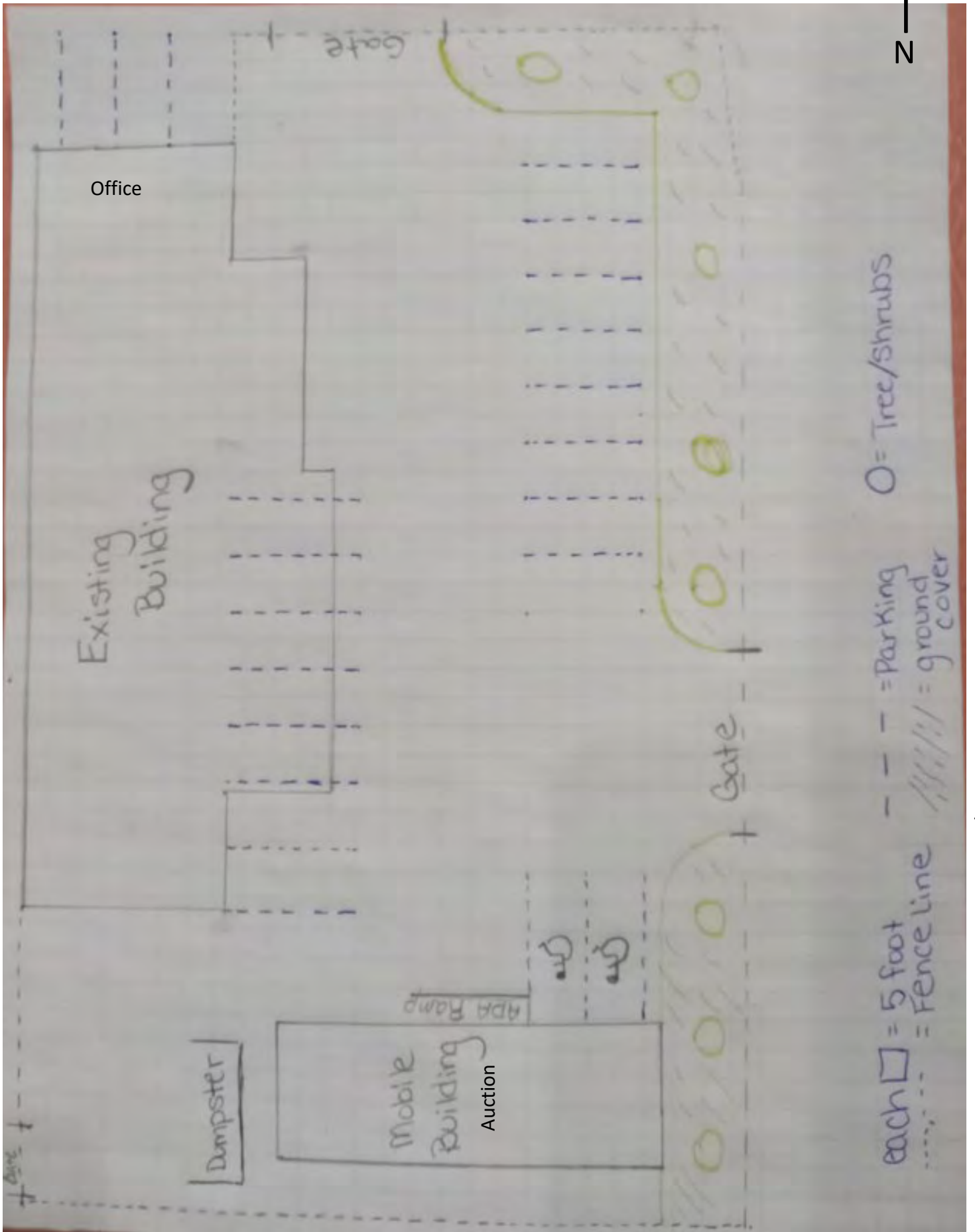
Use existing building for office, restroom and storage space. Install a Pacific Mobile Structure for conducting auctions.
