31 the ground and easy to maintain. He will install them before the end of 2025. The Board made some
32 suggestions for possible donations. Ray Sills moved, seconded by Owen Sharp, to approve the
33 donation request; all in favor.

47 the lights could enable soccer play during the winter months.
