



CAPITAL FACILITIES CHARGES - WATER AND WASTEWATER ORDINANCE NO. 2224 & NO. 2225

Centralia Municipal Code 15.04.060A and 15.10.350B - So that the property owners shall bear their equitable share of the cost of the water and wastewater system and as authorized in RCW 35.92.025 and RCW 35.92.035, there shall be paid a capital facilities charge at the time the application is approved for a water and/or wastewater connection based on the size of the water meter.

When a request or requirement for a larger size water meter is made, the additional capital facilities charge for wastewater will be the difference between the old water meter size and the new water meter size based on the current schedule of capital facilities charges.

On January 1st of each year beginning in 2012, capital facility charges shall be adjusted to reflect the annual percentage increase of the Engineering News Record Construction Cost Index as published for November of the preceding year. Calculation of the change in the index is made by dividing the current index for November by the preceding index for November and subtracting one.
